## **Financial Aid & Payment Options**

## **How to Apply for Financial Aid:**

- 1 Complete the Free Application for Federal Student Aid (FAFSA). The FAFSA is <u>available online</u>. If you do not have access to a computer you may request a paper version from the Financial Aid Office. Students should submit the 2025-2026 form. You will need your 2023 Federal Tax Return, your FSA ID, and Concordia University Wisconsin's code (003842). Graduate students are considered independent for financial aid purposes.
- **Review your Student Aid Report (SAR) for accuracy.** The Department of Education will notify you when your application is processed and will provide you with a Student Aid Report (SAR). If you notice any errors after reviewing your SAR, log back into your FAFSA to make corrections.
- 3 You will receive your financial aid award letter from Concordia once you have been academically accepted. This lists the financial aid you will qualify for. If you wish to decline all or a portion of the award, notify the Financial Aid Office in writing. Be sure to contact the Financial Aid Office if you have any questions on your award.
- 4 Complete Loan Entrance Counseling and the Master Promissory Note Entrance. Counseling is only required for first time Federal Direct Loan borrowers; all borrowers must complete a Master Promissory Note. Both can be completed at <a href="https://studentloans.gov/myDirectLoan/index.action">https://studentloans.gov/myDirectLoan/index.action</a> (you will need your FSA ID from Step 1).

## **Federal Loan Requirements:**

To be eligible to borrow funds under the Federal Direct Loan Program, you must:

- 1. File the Free Application for Federal Student Aid (FAFSA)
- 2. Be a U.S. Citizen or permanent resident
- 3. Not be in default on prior educational loans
- 4. Maintain satisfactory academic progress

## The Federal (Title One) Teacher Loan Forgiveness Program:

If you and your school qualify, this program may provide loan forgiveness for eligible Federal Direct Loans. This is a separate program requiring separate forms and processes. The U.S. Department of Education will determine your eligibility for this program. Concordia University Wisconsin is not responsible to verify your eligibility for this program. ## The TEACH Grant:

TEACH (Teacher Education Assistance for University and Higher Education) Grant (loan) is a merit based Federal Title IV program designed to encourage highly qualified teachers to serve in low-income schools in high-need fields. ## **Transcript Request Process**

Concordia University Wisconsin requires official transcripts from all previously attended colleges and universities to be fully admitted into the program of your choice. Follow the steps below to request transcripts from each of the schools that you attended.

## **REQUEST OFFICIAL TRANSCRIPTS:**

There are multiple ways to request transcripts, and each college or university will have their own process. Typically, the easiest way to order official transcripts is:

- 1 Contact the Registrar's office at your previously attended school, either by phone, email, or through your university's website.
- 2 Submit a transcript request following that school's procedures. Most colleges and universities require a signature or other official request in writing. Many schools have a Transcript Request Form available to download on the Registrar's website. Some will allow you to order transcripts online.

Note: Some colleges and universities charge a small fee for official transcripts. Be sure to enclose your fee with your transcript request to avoid a delay in processing.

It can often take several days for a transcript request to be processed. When your transcripts are received, the Graduate Information Office will contact you, but if you have not received confirmation within 14 days, please contact us at (262) 299–7350.

The student seeking a Wisconsin DPI counseling license endorsed by Concordia must complete a Portfolio and demonstrate an understanding and ability to apply the Pupil Service Standards within counseling practice. The Portfolio is comprised of five sections. The Introduction to Portfolio is completed while a student is enrolled in COUN 5000 Counseling Theories and Issues. Pre-Practicum Portfolio is to be completed and submitted as a part of the application process for participation in the Practicum experiences. The last 3 portfolio sections (elementary school, middle school, and high school) will be completed during the Practicum experiences.

## **Practicum Requirements**

The student must submit their entire application, with all three sites and on-site supervisors identified, for the practicum experience to be approved. Each student must obtain a minimum of 200 hours at each of the following levels: Elementary, Middle, and High. If the student must obtain more than 600 hours, they should contact the Program Director to review expectations and options.

### **Praxis II Exam Requirement**

Students must successfully complete the PRAXIS II exam before graduation.

## **Practicum for Professional Counselor**

The student seeking licensure as a Professional Counselor in Wisconsin will be required to complete 700 hours of practicum/internship experience. Each applicant must be supervised at each practicum site according to Wisconsin Department of Safety and Professional Services (DSPS) criteria and will be assigned a CUW site supervisor. A practicum agreement between the student, Concordia University, and each receiving site/agency/hospital are required for each practicum placement. The practicum allows the student to work as a counselor in a community setting and may include experiences such as assessment and implementation of counseling programs, individual and group counseling, and consultation with other community agencies. Applications for practicum can be made after prerequisite coursework is completed.

After graduation from the CUW Master of Science in Education-Counseling program, students will be eligible to apply for the LPC-IT license through DSPS. DSPS establishes the specific post-graduation requirements to receive the LPC-IT.
