9	Confirm Acceptance Offer & Pay Enrollment Deposit For an admissions decision, check your application account (https://connect.felician.edu/portal/admissions) for an admissions decision. In your account, "Reply to Offer of Admission" and pay the \$150 enrollment deposit. (Hover over "enrollment deposit" to click into a separate page to make payment.) Once deposited, Admissions can send your specific course registration options and will help register you. Roughly 48 hours after you are registered, IT will email your login information for the MyFelician hub. Advisors are assigned within the first two weeks of class. (https://felician.edu/my-felician/) and student email. Brightspace is used for courses and information will appear after 10:00am the Monday of start week. How to Apply for Financial Aid:

- 1** Complete the Free Application for Federal Student Aid (FAFSA) to be considered for federal and/or state grants. The FAFSA is **available online**. If you do not have access to a computer you may request a paper version from the Financial Aid Office. **Students beginning in Spring 2027 should submit the 2026-2027 form. You will need your 2024 Federal Tax Return, your FSA ID, and Felician University's code (002610). Graduate students are considered independent for financial aid purposes.**
- 2** Online processing time for the FAFSA takes 2-3 business days. The Department of Education will notify you when your application is processed and will provide you with a Student Aid Report (SAR). If you notice any errors after reviewing your SAR, log back into your FAFSA to make corrections.
- 3** **You will receive your financial aid award letter from Felician once you have been academically accepted.** This lists the financial aid you will qualify for. If you wish to decline all or a portion of the award, notify the Financial Aid Office in writing. Be sure to contact the Financial Aid Office if you have any questions on your award.
- 4** **Complete Loan Entrance Counseling and the Master Promissory Note Entrance.** Counseling is only required for first time Federal Direct Loan borrowers; all borrowers must complete a Master Promissory Note. Both can be completed at <https://studentloans.gov/myDirectLoan/index.action> (you will need your FSA ID from Step 1).

Federal Loan Requirements

To be eligible to borrow funds under the Federal Direct Loan Program, you must:

1. Apply for a Masters or Doctoral program as a fulltime degree-seeking student
2. File the Free Application for Federal Student Aid (FAFSA)
3. Be a U.S. Citizen or permanent resident
4. Not be in default on prior educational loans
5. Maintain satisfactory academic progress

Enrolling in an Interest-Free Monthly Payment Plan:

The University offers payment plan options that are simple, inexpensive, and convenient. The Federal (Title One) Teacher Loan Forgiveness Program:

The TEACH Grant:

The TEACH (Teacher Education Assistance for University and Higher Education) Grant (loan) is a merit based Federal Title IV program designed to encourage highly qualified teachers to serve in low-income schools in high-need fields. Grant recipients agree to teach for at least four years within eight years of finishing their teacher preparation program and to teach high-need students in designated schools that serve low-income students. This is a separate program requiring separate forms and processes, including using financial aid to pay for your current program. The U.S. Department of Education will determine your eligibility for this program. Felician University is not responsible to verify your eligibility for this program. Transcript Request Process

Official transcripts from all colleges and universities attended are required. Transcripts should be mailed or sent electronically to Felician University's Registrar directly from institutions previously attended, or they may be sent by you if mailed in an envelope signed and sealed by the registrar's office of an institution. **Felician requires a 3.0 GPA.**

Prerequisite Requirements:

- Should your program require any prerequisites, you must provide an official transcript before your program begins
- You must provide all official conferred degree transcripts before your program begins
- Failure to submit required official transcripts by the defined deadlines can result in a revocation of admission

REQUEST OFFICIAL TRANSCRIPTS:

There are multiple ways to request transcripts, and each college or university will have their own process. Typically, the easiest way to order official transcripts is:

- 1 Contact the Registrar's office at your previously attended school, either by phone, email, or through your university's website.
- 2 Submit a transcript request following that school's procedures. Most colleges and universities require a signature or other official request in writing. Many schools have a Transcript Request Form available to download on the Registrar's website. Some will allow you to order transcripts online.

Note: Some colleges and universities charge a small fee for official transcripts. Be sure to enclose your fee with your transcript request to avoid a delay in processing.

- 3 It can often take several days for a transcript request to be processed. When your transcripts are received, the Graduate Information Office will contact you, but if you have not received confirmation within 14 days, please contact us at (551) 288-1230.

For:

Individuals who wish to earn a Master's degree in Educational Leadership including Principal and Supervision Certification. Candidates need 3-5 years of teaching experience under the standard license to be eligible for certification in the state of New Jersey. Individuals who wish to earn a Master's degree in Educational Leadership including Principal and Supervision Certificates. Candidates need 3 years of teaching experience under the Standard license to be eligible for Supervisor Certification in the state of New Jersey. Candidates need 5 years of teaching experience under the Standard license to be eligible for Principal Certification in the state of New Jersey. Candidates with a Master's degree & evidence of 3 years teaching (Standard licensure required) are eligible for nomination for the Supervisor Certification through the NJDOE upon completion of the 12 credit sequence. Candidates with a Master's degree & evidence of 5 years teaching (Standard licensure required) are eligible for nomination for the Supervisor and Principal Certifications through the NJDOE upon completion of the 30 credit sequence (Phase I & Phase II). Candidates must successfully pass the required SLLA exam. Supervisor and Principal applicants must hold a Masters degree in Education or an educationally-based content area.

To uphold a position as both an educator and a leader in the community and in diverse school settings, you will develop a strong understanding of the philosophies and principles guiding various leadership models. For:

Teachers who want to earn a Master of Arts Education with Teacher of Students with Disabilities Endorsement. Candidates must be in possession of a CEAS or Standard initial teaching license in P3/K6/K12 to be considered. A CE does not meet the requirements for this program. The TOSD endorsement adds on to your current teaching license.

What You Learn:

- This program will prepare you to create a classroom setting that is inclusive, compassionate, and fosters a community of support for learners with disabilities. By learning skills and knowledge such as behavioral observation methods, evidence-based practices for those with Autism Spectrum Disorder and other developmental disabilities, and ethics and professional standards, you'll become equipped with the understanding necessary to help teach and improve the lives of uniquely-abled students.
- You'll learn how to support positive behavior, promote inclusivity, help ease the transition into adulthood, and more. You will also gain a deep knowledge of current laws and technologies that affect special education and how to design curricula in inclusive environments. Discover how to help maximize the potential of uniquely-abled learners to create and sustain independence in their lives and make meaningful gains.

Professionals who want to earn a Master's of Arts in Education with Applied Behavior Analysis and Autism Studies Certificate. If you hold a master's degree, you can earn the Applied Behavior Analysis & Autism Students Certificate only.

What You Learn:

You can help to better the lives of individuals with Autism Spectrum Disorder (ASD) and other Developmental Disabilities (DD) that are impacted by behaviors ranging from difficulty with communication, academic, social, and functional skills. Discover how you can play a central role in helping those with ASD and DD gain a better quality of life by applying an effective systematic, scientific approach: Applied Behavior Analysis.

How You Learn:

Courses are offered in both an asynchronous and synchronous online format with weekly evening Zoom classes determined by each professor. Typically, students take two to three, 16-week courses per semester (Spring, Summer, and Fall semesters). Though we are striving to find placements and BCBA® fieldwork supervisors for all students, Felician University cannot guarantee practicum placement. We are striving to assist each student by organizing a list of potential supervisors and sites. To find a qualified supervisor, check out the BACB's registry of BCBA's ® willing to supervise candidates pursuing BCBA®. Students are responsible for successfully completing all degree requirements. To be eligible to sit for the BCBA® exam, students are also responsible for accumulating 2000 supervised fieldwork hours, submit all documents that are required. Completing 2000 hours is not a requirement for program completion. To become a BCBA®, students must pass the BACB Task List V BCBA® Exam. Passing the BCBA® exam is not a requirement for degree completion. If additional practicum is not taken, the student will be required to complete additional supervised field work hours outside of the practicum course independently to qualify to sit for the examination. Felician University's Graduate Courses in Behavior and Autism Studies is a Verified Course Sequences (VCS) by the Association for Behavior Analysis International, and the core course sequence is approved by the Behavior Analyst Certification Board® (BACB®). The BACB is the only credentialing organization for professionals within the discipline.

Career Outcomes:

This program will prepare professionals to understand behavioral patterns in relation to the environment and help support prosocial behavior in individuals with unique abilities. Through active class discussions of course materials and a field experience, students gain the knowledge and skills needed to understand and work effectively with people from diverse backgrounds and settings using the principles of Applied Behavior Analysis.

Teachers who want to earn a Master of Arts in Education with LDTC Endorsement. If you have a master's degree specifically in education (special education and reading also considered) and have 3 years of teaching experience under your standard license, you can earn the LDTC Endorsement only.

LDTCs also consult with parents, teachers, and other school personnel to provide research-based instructional strategies to assist pupils who are struggling academically.

This admission option is for students who have been enrolled in a doctoral program at another institution and have not been able to complete their doctoral degree at another institution. Students with this advanced standing will be able to transfer credits from a previous doctoral program up to 30 credits.

6. Copy of your Standard or CEAS New Jersey Teaching License (Required ESL, Educational Leadership, LDTC, Principal, Supervisor, & TOSD programs)
7. Personal Statement (Required for EdD, ABA, ESL, LDTC, School Counseling, TOSD, IDT, & Traditional Route Teaching Licensure programs)

Transfer Credits

We can consider accepting 6 credit hours into our Certificate & Masters programs and 15 credit hours into our Doctor of Education programs, taken within the past 10 years, provided they are directly related to the program for which you are applying. Please fill out a transfer credit review request form and include course descriptions or a syllabus. When you have been accepted, our program director will then review for any possible transfer credits. Felician will accept only two transfer credit requests per student, totaling a maximum of two courses for review. Once a **transfer request** is submitted, if the courses are accepted, they cannot be substituted. If the courses are not accepted, you may submit one additional request, but no more. If you have not yet been accepted, an ID has not yet been generated for you. You may enter any character into the ID field as a placeholder in the meantime.
